

Report of LASWEB for the year, 2018-2019

Meetings

❖ **Barasat Division of LASWEB:** Unfortunately, the building as well as Habra Property of **LASWEB** could not be given a share either on account of non-cooperation of the erstwhile Developer of the Sisir Kunja or failure on the part of the property to provide us with the original documents in relation to the Habra. I sincerely hoped by the keen attention of our distinguished members dealing with the same or entrusted to do the same to consider the issues effectively.

❖ **REPORT ON PGDCC(2018-2019), BYDR. BARUN KUMAR DAS, COURSE DIRECTOR**

The members are aware that the condensed course of short duration on the Family Counselling conducted by LASWEB over the years, had been the inspiring factor to introduce the Post Graduate Diploma Course in Counselling for the duration of one year, Affiliated to The University of Calcutta, since 2014 with the First Batch of Scholars.

The course continues with the 6th Batch in 2019 with 31 enrolled scholars. Apart from school and college teachers, N.G.O Executives, there are ten Police personnel of West Bengal Police, Alipore, Bhabani Bhawan, Government Employees, Editor of Newspaper, Retired Employees, Home Makers, Social Workers, one practicing Advocate and other general scholars. The course is in great demand among the scholars who are interested for the balanced curriculum and practical approach of training, interactive session like group counseling role play etc and model classes in

counseling. The course also takes care of skills of communication, oratory, self expression and developing human relationship with practical demonstration. Many of our passed out scholars have been engaged in different schools and establishments of N.G.O as Counsellors. Few of them have started their own organizations in counseling. Recently it has been seen that there is a growing demand of trained counselors in various institutions, courts of Law, Hospitals, Universities and Correctional Homes.

On 30th March,2019 (Saturday) Convocation Ceremony of 5th Batch, 2018 was held at Auditorium of Shikshayatan Foundation. Total 43 scholars were awarded with Diploma Certificates and Mementos.

❖ **INTERNSHIP OF STUDENTS AT LASWEB**

LASWEB has trained several students in the placement scheme after they had joined as Internees from different Law Schools, Colleges and Universities.

All the students who approached the **LASWEB for internship** were provided with study materials, the history of cases done by the **LASWEB** from time to time and they were also granted certificates by our office in order to enable them to produce the same to the respective colleges as a record of their participation in this programme. As many as **18 internees** successfully completed the internship program during the year.

❖ LASWEB'S INITIATIVES IN PUBLIC INTEREST LITIGATIONS

Over the last several years, **LASWEB** has initiated several public interest litigations in the interests of Justice and Social Welfare. The stated objective of the organization is to come to the help of the hapless people to ensure all round effort and to bring dignity to the life of the people, and to intervene wherever there is a violation of Fundamental Rights and also to ensure preservation of Constitution rights wherever there is any violation.

LASWEB has taken an initiative by filing a Public Interest litigation related to the matter of Construction of Thermal Power Plant at Mejia in the District of Bankura by the Damodar Valley Corporation. On behalf of **LASWEB**, Ms. Soumi Guha Thakurata, Advocate filed the PIL, bearing O.A NO. 152/2017 before the National Green Tribunal. The PIL is still pending. **LASWEB** is continuing its ever vigilant monitoring of the case.

FUTURE PLANS OF LASWEB

- ❖ **SHORT STAY HOME** : For extending legal aid and assistance to the destitute women, we had to face certain impediments for providing short stay home for those who have been thrown out of their matrimonial home. We have a plan for providing short stay home in the building/house property at Silpara, Behala, South 24 Parganas.
- ❖ **SENIOR CITIZENS' HOME(NABA NIBAS)** :We are glad to announce that our attempt for construction of Senior Citizens' Home at Shakuntala Park, Behala is progressing in right direction. The property at Shakuntala Park, where our three storied Senior Citizens' Home is requisite to be constructed, necessary sanction from the Kolkata Municipal Corporation has been obtained. **The Executive Council, LASWEB decided to take steps for construction of building for old age home** for Old Age Home (**Naba Nibas**) at **29, Shyam Sundar Pally Main Road, Shakuntala Park, Kolkata- 700 60 in collaboration with the developer M/S Loknath Developers** who has been assigned for constructing Building as per Development Agreement and Sanctioned Plan of the said area. **Mr. M. P. Chakrabarty, Executive Chairman, LASWEB** has been entrusted to execute **Development Agreement** and **Power of Attorney** with and in favour of **M/S LOKNATH DEVEOPERS** represented by three partners, **Mr. Soumitra Sarkar, Ms. Ruma Ghosh and Mr. Bappa Chatterjee**. Resolved further that **Mr. M. P. Chakrabarty, Executive Chairman** be and hereby entrusted to execute Development agreement with and in favour of **M/S Loknath Developers**, represented by its partners.

A FEW WORDS ABOUT THE LATEST PROJECT

You may be aware of the activities of this social welfare organization, **Legal Aid Services West Bengal (LASWEB)**, committed to stand by the downtrodden and needy, in the field of legal aid and counselling. We have organized Lok Adalats, Legal Aid Camps, Workshops, Seminars, for the past five decades, apart from conducting Family Counselling Training Courses.

You will be glad to know that we have launched a new Project "I AM NOT ALONE...Care for the Elderly", focusing on the elderly people, who are victims of neglect, deprivation, exploitation, and disrespect, at times, even from their own family members. Their contributions of the past have been forgotten, and they are left to fend for themselves and perish. No one, including ourselves, can consider himself/herself to be immune from the agonies of loneliness, helplessness, disease, desertion in old age.

This alarming situation has prompted LASWEB to create a much needed comprehensive setup to provide legal, medical and psychological, and even domestic assistance to these elderly citizens. We have named this geriatric care project of LASWEB as "I AM NOT ALONE"...Care for the Elderly. The task is gigantic, but a beginning has to be made. We will train care-givers to visit the enlisted families regularly, and provide various sorts of assistance. The primary requisite for all these care givers, is possession of compassion and an urge to help others.

We will liaise with police, lawyers, doctors, teachers, social workers, to make a perceptible and positive difference in the lives of the elderly people in our society.In order to provide proper care and quality time to these beneficiaries, college students and counselors will be trained as "care givers". They will visit them twice a week and offer all assistance to the elderly, against a nominal honorarium. Lawyers, doctors, social workers and others will be sensitized so that they can lend their help to the elderly, at subsidized cost. The project is being managed by **Sri Anjan Chakraborty as Director**, and a committee has been set up for this purpose. The project was inaugurated on **20th May, 2017 at 4.00p.m.** at the **Shri Shikshayatan Auditorium.**
